July 1 - Refereeing

I recommended to the National Officials Advisor Council that the level two accreditation for one of our BC referees be removed. This referee's performance at the recent Kamloops Open tournament was very substandard. After he refereed a few matches, the tournament Head Referee removed him from refereeing in the tournament. The tournament head referee then sent the disciplinary report to me. I also received information that this particular referee was removed from refereeing in an Arizona tournament this past winter. Based on scorekeeping errors, game management issues, and incorrect score sheet completion, I recommended to the Council that his Pickleball Canada referee credentials be removed until the referee can re-enter the accreditation process and earn new credentials. The Council unanimously agreed. I can provide more information verbally at our meeting on Tuesday if there are any questions.

I have also received a request to hold an officiating training session in the northern part of our province. Depending on budgetary and timing factors, this session may occur this fall.

June 30th Membership Report

No new Clubs completed the necessary organizational process to begin registrations this month. North Shuswap, Qualicum, Shawnigan Lake and qathet (Powell River) have begun the process and I had zoom calls with the last 3 this past week. This brings us to 88 Affiliated clubs, 4 in progress and 2 Associated organizations, up 16 Clubs from this time last year.

There were 941 registrations in June, 305 renewals and 636 brand new PBC members. Again this month, new member numbers were higher than renewals.

As of June 30th, there were 14,050 active PBC memberships, far more than we had at the end of 2022 and an increase of 3,466 over this point last year. There are still 2500+ members who expired in 2022 and have not yet renewed. Last year we gained 1609 new members between July 1 and the end of the year. As well, 904 expired members renewed between June 1 and September 30th when renewals carried membership over into 2023. We could easily reach almost 16,000 members this year if that growth occurs again.

No new National data has been provided to compare our results with, although they advertise that there are 50,000 PCO members, which makes BC approximately 28% of the total membership.

Report to the July 4 Board Meeting Facilities Development

Since our last meeting some more clean up and clarification work was done on our Pickleball Guidelines document and then sent to all club presidents. One such president felt so concerned that we weren't pushing for better standards that she wrote to all others asking them to contact me directly with what they wanted to see included. Two did, no further changes required as a result. Our recommendations already dovetail with USA Pickleball's information, which is supported by PCO. We have received several votes of confidence in our report and process. Sometime this year we expect BC Recreation & Parks to come back to the table with their version of the project.

I've been working with a few clubs around securing new courts, most recently Qualicum Beach. They had an agreement with their town council to double line a tennis court for this year, but that was just postponed while they re-surface the courts. Their council has offered \$85,000 to the club towards dedicated courts if they can match that through their own fundraising. The tennis players are very active in lobbying council and staff against pickleball use of the existing tennis court.

Others who are working on court shortage solutions or noise avoidance issues are: Fernie (keep this quiet for now), Gold River, Nanaimo, Courtenay-Comox, West Vancouver and Gallaghers Canyon.

Parksville just opened their re-furbished facility in the Community Park, which went from 4 tennis courts to 2 tennis courts (double lined for pickleball) plus 4 dedicated pickleball courts. Until now, there was no drop in pickleball anywhere in Parksville. This result came about after over 5 years of conflict, discussion, and compromise.
