Rick Folk Head Referee, Pickleball BC

We have one new Certified Referee in Canada and she is from Penticton. Congratulations to Dianne Hill who achieved her certification in Regina at the National Championships. We now have 9 certified referees in BC.

I will not be conducting a referee training session this fall in Northern BC. There was not an adequate sign-up to proceed.....so, hopefully next year.

However, I will be leading a referee training session on October 19, hosted by the Nanaimo Pickleball Club.

On September 15 to 17, I will be attending the Surrey Cup in Surrey. I will be refereeing in the tournament, as well as conducting some referee assessments. I was talking to the tournament coordinator, and she is looking for volunteers to help out during the weekend. If you have any suggestions, please let me know, and I will pass them along.

I hope to have an information message ready for our next PBC newsletter. In it, I will outline the process for interested pickleball players to become an accredited pickleball referee. As you may recall, we (I) ran into some uncomfortable, unexpected situations having assessments done this past spring. I felt there were three factors that contributed to the problems. One, some of the candidates were not aware of the preparations that were required. Two, the scheduling was not right....we tried to do too many assessments in too short of a time period. Three, I was a rookie Head Referee.

In consultation with Sharon (Referee Training Coordinator for the West), we are going to ask that each candidate be recommended for assessment by a referee trainer or accredited referee, and that Sharon and/or I be notified of any plans for assessment. I will also make sure that adequate time is allocated for the assessments to take place. Finally, I feel that I am somewhat of a grizzled veteran head ref.

August 31st Membership Report

Two new Clubs completed the necessary organizational process to begin registrations this month, Cortes Island and Abbotsford have now begun the registration of members. This leaves us at 91 affiliated clubs, 1 in progress (Qualicum) and 2 Associated organizations, up 15 Clubs from this time last year. I have begun the process to remove a couple of defunct clubs from the system as The Pickleball League and Vancouver Island Pickleball Association have gone dormant. VIPA is and was Ken Holman's organization and he hopes to pass it on to someone, but there are no takers. More clubs may follow.

There were 634 registrations in August, 216 renewals and 418 brand new PBC members. Again, this month, new member numbers were higher than renewals, continuing the trend began in May 2023. August 2022's Membership registration numbers were 332/219/113, so we are almost double last years trends.

As of August 31st, there were 15,294 Active PBC memberships, far more than we had at the end of 2022 and an increase of 3963 over this point last year. There are still 2500+ members who expired in 2022 and have not yet renewed, though a number of them have rejoined in the past 2 months. Last year we gained 1300 new members between September 1 and the end of the year. We could easily reach 16000 members this year if that growth occurs again.

October 1 is the rollover date for renewals to carry forward into the end of 2024. I have place a notice on all club registrations pointing this out. It should slow down new member applications this month, but we did have 49 newbies last September.

No new National data has been provided to compare our results with.
