New Applications: Pending

February 2023 Membership Report – Rod Williams

Six New Clubs completed the setup process in February and are accepting Memberships – Tofino, Port McNeill, Naramata, Peninsula Community (Saanich), Global Indoor (Kelowna) and Metchosin.

Sicamous just appeared in my inbox today seeking info.

There are currently 91 BC clubs and affiliates launched and processing memberships through PCNS.

Registrations.

1354 memberships were processed during February. 522 or 39% are brand new PCO Member numbers and the rest are renewing or previously expired members. Last month's newsletter and the recent BC Provincials instructions mentioned the need for people to register themselves properly so their PCO and Pickleball Brackets profiles align to the same PCO number. There are currently roughly 100 duplicate members listed in our Member List. While I can merge their all of their profiles into one Membership number, I cannot determine which PCO number they may have used with Pickleball Brackets, making a decision on which number to use problematic, so I wait for them or their club to complain.

As of February 28th, there were 9627 Active PBC members, with 7760 inactive and expired member, including both 2021(3098) and 2022 (4659) expiries. Both totals are lower than last month. There are a few legacy 5 year PCO memberships still active, but they should all be gone in 2023.

National PCNS News - Nothing new

December 31 year end Analytics indicated that, BC accounts for 28% (down 1% since August) of all PCO memberships, and has provided 36% (up 3%) of all the revenue generated by the PCNS system



Report submitted March 3, 2023 Rick, Head Referee

- 1. Walter has finalized an agreement with Pickleball Depot for a three year (confirm) sponsorship of the Pickleball BC Referee Program.
- 2. I have started the process of ordering referee shirts for all of our Level One and Level Two BC referees. There are about 18 right now. Pickleball Depot will sponsor these shirts. Will have REFEREE on back, our two PBC logos (round on left chest, banner on arm), as well as Pickleball Depot logo on other arm. These will be yellow in color.
- 3. Pickleball Depot is also sponsoring white polo shirts for us members of the PBC Board. No REFEREE on back. PBC banner logo on left chest with Board Member underneath, PBC round logo on one arm, and Pickleball Depot logo on other arm.
- 4. The Pickleball BC Traveling Referee Compensation Program is ready to begin. \$400 per qualified level 2 or Certified Referee. Non-BC refs also eligible. Must travel over 150 km from home. Referee at least 35 (still to be decided) matches at our Provincials. Sole purpose to referee (not play). Be member of Pickleball Canada. If a second credentialed referee in the household, he/she would receive \$200 instead of \$400. The number of matches will be verified by the Vernon Committee, approved by PBC Head Referee, and submitted to PBC Treasurer for payment.
- 5. My estimated expenditure for the above program is between \$6000 and \$8000.
- 6. Pickleball Alberta has instituted a similar program, but has capped its expenditure at \$4000.
- 7. Pickleball Saskatchewan has also started a similar program. \$350 for eligible referee, but only for Level Two referees, not Certified Referees.



8. I have received 3 inquiries about joining our BC accredited referee program, and also have had requests to travel to parts of BC to conduct training and evaluation sessions. I am beginning to work with Sharon MacDonald (Pickleball Canada Referee Training Coordinator for Western Canada) on how to best train and evaluate interested referees. Sharon and I are both new in our positions.
