

Associate Memorandum of Understanding

This Memorandum of Understanding (MOU) is a cooperative agreement between:

Pickleball BC Association (PTSO)

and

Name of the applicant, herein after the Associate Organization

Purpose and scope

The purpose of this MOU is to set forth the terms and conditions, responsibilities, authorities and any other deliverables or matters of mutual interest between the parties to this MOU.

At a high level the purpose of this cooperation is the promotion and facilitation of pickleball!

Eligibility

This MOU is drawn with respect to 'Associate Organization' status. Associate Organizations may be multisport organizations, educational institutions or service clubs. These organizations may not have pickleball as their sole focus but may have interest and opportunity to promote pickleball play. This in contrast to Affiliated pickleball clubs whose sole purpose is the promotion of pickleball.

Opportunities for Associates

- recognition on PTSO and Pickleball Canada websites
- use of PTSO and Pickleball Canada logo and other material with conditions
- ability to host Pickleball Canada sanctioned tournaments
- access to NCCP pickleball training
- access to Pickleball Canada Officiating training PCO members only
- possibility for grants from PTSO and Pickleball Canada
- inclusion in relevant communiqués from PTSO and Pickleball Canada
- formalized opportunity to provide feedback re current issues

Associate Responsibilities

- promote and facilitate pickleball to their best capability
- encourage all pickleball players to join Pickleball Canada
- in so far as possible ensure pickleball play is in compliance with the PCO/IFP rules
- wherever possible meet or exceed PTSO and Pickleball Canada safe sport, equality and inclusion polices



Fees and Costs

Fees for an Associated Organization and individual members are independent of each other.

The fees to join as an Associate Organization will be comprised of two parts - a PTSO component and a Pickleball Canada component, each on an annual basis. The combined fee amount will be remitted to the PTSO.

Individual members shall be encouraged to join the PTSO, and thereby Pickleball Canada as well, via links on either or both the PTSO and Pickleball Canada websites.

Limitations

Associated Organizations are responsible for their own insurance, making certain the chosen facility is suitable for the activity, all Public Health and other Government regulations are followed and full and total management of all related pickleball activity.

Pickleball Canada and the PTSO may be able to provide guidance and in some circumstances may have Policies that should be observed as well.
